

**BOROUGH OF FRANKLIN LAKES  
ORDINANCE 1685**

**AN ORDINANCE AMENDING ORDINANCE NO. 1676 TO INCREASE  
THE APPROPRIATION FOR THE PURCHASE OF VARIOUS ITEMS  
AND CERTAIN CAPITAL IMPROVEMENTS FROM \$310,000 TO \$318,000**

**WHEREAS**, Ordinance No. 1676 appropriated the sum of \$310,000 for improvements to Huron Road and Old Mill Road, Police Headquarters renovations, and digital tax maps; and,

**WHEREAS**, it is necessary to include an additional \$8,000 in the appropriation for improvements to Huron Road and Old Mill Road as certain costs were inadvertently not included in the original appropriation;

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Franklin Lakes, in the County of Bergen, New Jersey, that Ordinance No. 1676 be and is hereby amended to read as follows:

**Section 1.** (a) Pursuant to the applicable statutes of the State of New Jersey, the purposes described in Section 2 of this ordinance, together with other purposes appurtenant or incidental thereto or therefor, are hereby authorized to be made or acquired by the Borough of Franklin Lakes, in the County of Bergen, State of New Jersey (the “Borough”).

(b) It is hereby determined and declared by this Borough Council of the Borough that the estimated aggregate maximum amount of money to be raised from all sources for the purposes stated in Section 2 is \$318,000.00. In order to finance the cost of the purposes stated in Section 2, there is hereby appropriated to said purposes the sum of \$318,000.00, being inclusive of all appropriations heretofore made therefor, amounting in the aggregate to \$318,000.00, and said sum is hereby appropriated from the sources described in Section 2 for said purposes.

**Section 2.** The purposes hereby authorized, the estimated costs thereof, and the sources of appropriation therefor, are as follows:

Digital Tax Maps	\$80,000.00	Capital Improvement Fund

**Section 3.** The following additional matters are hereby determined, declared, recited and stated:

The purposes described in Section 2 of this ordinance are not current expenses and purchases which the Borough may lawfully make as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

**Section 4.** Any grant or other moneys received for the purposes described in Section 2 hereof shall be applied to the payment of the costs thereof.

**Section 5.** The capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board of the State of New Jersey, Department of Community Affairs, showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Borough Clerk and is available there for public inspection.

**Section 6.** To the extent that any previous ordinance or resolution is inconsistent with this ordinance or contradictory hereto, said previous ordinance or resolution is hereby repealed or amended to the extent necessary to make it consistent herewith.

**Section 7.** The provisions of this ordinance are severable. To the extent any clause, phrase, sentence, paragraph or provision of this ordinance shall be declared invalid, illegal, or unconstitutional, the remaining provisions shall continue in full force and effect.

**Section 8.** This ordinance shall take effect at the time and in the manner provided at law.
