General</p> <p>To the Residents of the Borough of Franklin Lakes:</p> <p>The attached 2015 Municipal Budget reflects the amount of appropriations necessary to run the daily municipal operations of the Borough. These amounts are for the municipal operations only, as the Mayor and Council have no control over the school and county budgets.</p> <p>The 2015 Local Municipal Budget presented herewith indicates an estimated tax levy for local municipal and library purposes of \$11,431,594, which represents a 1.76% increase over the 2014 tax levy of \$11,233,414.
