




Inspections - Code Enforcement Official



Revenue from Registered Abandoned/Foreclosure Properties




Revenue from Registered Abandoned/Foreclosure Properties: The amount collected from registered foreclosure and nuisance properties. Registration fees are due by the end of the year for the forecoming years' registration. Registration for 2020 Abandoned/Foreclosure Properties has an estimated revenue of \$59,0000.

There have been 119 foreclosure properties registered to date, 74 properties deregistered to date and 45 properties registered as an active foreclosure property at the end of 2019. Foreclosures are deregistering (being bought by a private party in good standing) 30% more than new foreclosure registrations for the past two years.


In 2020, 3 of the 8 Nuisance Properties Registered have been deregistered. Two have been sold to private parties in good standing and one property has maintained compliance of property maintenance standards as requested by our Code Official.

Notice of Violations Sent



Notices of Violation: Notice of Violations issued for infractions of our Borough Code which include Property Maintenance, Shade Tree, Engineering, Nuisance, Foreclosures, and Zoning Issues. December yielded a higher number of violations, due to warm weather swings prolonging leaf season, tree limbs hanging low/dead/hazardous, and snow storm clean up for both residential, foreclosure and nuisance properties.

Summons Issued



Summons Issued: Number of Summonses issued after a property owner or business fails to remediate a Violation after a Notice has been issued, for repeat violations on the same property or for violations which pose a threat to life safety.
