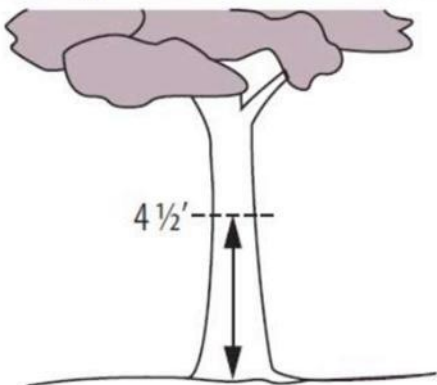

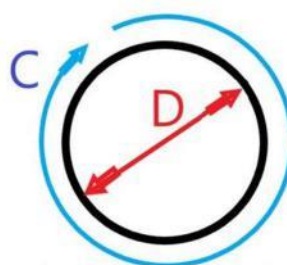
In your sketch, include the road your house is on, your house, and driveway in relation to the tree(s).

Trees are 7" or larger in diameter at breast height (DBH), measured at 4.5' above ground – when the trunk splits below DBH, it is 2 trees. See below. All trees proposed for removal MUST be marked with TAPE ONLY around trunk.

5. Tree replacement mitigation schedule

Replacement Schedule and Mitigation Requirement

Upon approval of a permit to remove live tree(s), applicant shall, at their expense, plant tree(s) in the place of tree(s) removed as per the Tree Mitigation Schedule below. A cash or surety bond shall be posted by applicant for the planting of replacement trees in the amount of \$500 per replacement tree prior to issuance of a tree removal permit. The bond shall be returned to applicant upon approval by the Tree Specialist of the proper planting of replacement trees.

In cases where, in the discretion of the Tree Specialist, the planting of new tree(s) in place of the tree(s) removed would not be feasible, applicant shall pay a fee in the amount of \$500 per replacement tree. Said fee shall be paid prior to issuance of a tree removal permit.

- **Replacement trees shall be planted in the next planting season – either before June 1 or after October 1.**

- **Minimum required size of replacement trees: (See Recommended Tree List)**
 - **Deciduous replacements are required to be no less than 2.5" in caliper.**
 - **Coniferous replacements are required to be 8' to 10' in height.**
- **No substitutions of replacement tree varieties permitted without prior Borough written approval.**

APPLICANT SIGNATURE

By signing the application below you are acknowledging the requirements for tree replacements AND the penalties for violations of the tree removal permit requirements:

§ 300-157 **Violations and penalties; costs charged against lands; enforcement.** Violations and penalties. Any person violating any of the provisions of this article shall be subject to a fine of **not less than \$500 nor more than \$5,000 per tree** and/or imprisonment in the county jail for a period not to exceed 90 days and/or 90 days of community service. Each tree damaged, removed or destroyed in violation of this article shall be considered a separate offense, and a separate fine shall be levied for each tree. In addition, the court shall require the guilty party to replace trees that have been removed or damaged in violation of this article, in accordance with the tree replacement schedule in Section 300-152 of this chapter.

The applicant, by applying for this permit, is authorizing Borough personnel to access the property for tree inspections.

Tree planting will be completed as per Tree Mitigation Schedule - A cash or surety bond shall be posted by applicant for the planting of replacement trees in the amount of \$500 per replacement tree prior to issuance of a tree removal permit. The bond shall be returned to applicant upon approval by the Tree Specialist of the proper planting of replacement trees. *Note: Tree planting required within 6 months of permit approval.*
